### TIME & SETUP

The market will be a 1 day event and will be open from 9am until 4pm on Saturday, October 29, 2016. Setup will begin at 10AM on Friday, October 28 and booths must remain in place until 4pm Saturday.

### BOOTH SPACE & TABLES

Each booth or food truck space size will be as specified in rate chart. Each booth will include 1 plastic 60" round table and chairs for non-food vendors. Beautiful rectangular reclaimed wood tables available for \$10 rental fee (specify on application). Picnic tables will be available for use by food truck patrons.

Booth fee is due in full no later than September 30, 2016. Applications received past this date will be considered if space remains. Electricity must be requested in advance. Specific booth locations will be at the discretion of the Market Committee.

### TAXES

Cotton Gin Market is responsible for collecting state (Mississippi) sales taxes. All Artisans are responsible for collecting sales tax (7%) as required by law. Taxes collected must be turned into the Market Committee in the tax envelopes provided. A representative of the Market Committee will collect taxes during the last hours of the market on Saturday.
